## PILLAR 1

# OUR PLANET

**Portwest is committed to implementing more sustainable activities into our operations and reducing our impact on the environment.**

Portwest has achieved ISO 14001 certification at sites covering 75% of employees, which demonstrates our hard work to set up fully integrated and proactive environmental management systems. This system enables us to measure resource efficiency and effectively manage the environmental impact of our operational activities. We are working towards global certification.

## CERTIFICATION

We have achieved Level 2 in STeP by Oeko-Tex® for ecological and socially responsible textile production in our Bangladesh manufacturing facility.

STeP stands for Sustainable Textile Production and is a global certification system for environmentally friendly and socially responsible production facilities in the textile industry.

Our 2025 assessment highlighted that our management unanimously supports sustainable production by providing the appropriate resources.

## CLIMATE COMMITMENT

Portwest is committed to acting on global climate change. We have calculated our global carbon footprint for Scope 1 and Scope 2 emissions, reducing carbon intensity from 1.65 in 2019 to 0.86 in 2021. We aim to continue working towards further reductions while establishing our climate transition plan and implementing projects to lower emissions.

## ENERGY EFFICIENCY

In 2023, our warehouse in Spain received their solar panels marking the first step on Portwest's journey of investing in renewables. Our carbon footprint analysis has enabled the identification of hotspots across the organization, and we actively exploring solutions for each site. Our head office installed solar panels in 2024. The remainder of electricity sourced for this site from our energy provider is 100% renewable. Solar panels are also being implemented at our UK warehouse.

## WASTE REDUCTION

Managing waste effectively is a priority for Portwest, and are working towards our long term goal of zero waste to landfill. Our waste reduction efforts are guided by our Environmental Management Systems (ISO 14001), which defines our practices related to the handling and disposal of operational waste. Our investment in manufacturing innovation, such as automated fabric cutting tables, helps reduce fabric waste.

While waste management is guided by legislation at several of our sites, we are in the process of implementing better recording and management of waste at all other sites. By the end of 2025, we aim to improve markers for each site based on infrastructure available in each country.

## WATER CONSERVATION

Since our owned facilities focus mainly on warehousing, sewing, and finishing, water usage at Portwest is primarily domestic. By monitoring our water consumption, we quickly address leaks and ensure efficient water usage.

## SUSTAINABLE LOGISTICS

Selling in over 130 countries means Portwest transports goods worldwide, with less than 5% of stock moved via air freight and we are actively working to reduce this even further.

We are working closely with our logistics suppliers to ensure our strategies align to reduce negative impacts and carbon emissions across the globe. All our significant logistics suppliers have published their transition plans, and we are working with them to understand the impact of our shipments which we will have finalized by the end of 2025.

# OUR PRODUCTS

**At Portwest, we are dedicated to increasing the use of certified sustainable and recycled materials in the manufacturing and packaging of our products.**

In 2021, we launched a new range of products, using sustainable materials, such as recycled polyester made from 100% PET consumer waste and organic cotton. We continue to expand the number of products using these materials to grow this range further.

## QUALITY AND DURABILITY

All our fabrics and products undergo rigorous in house and independent testing, before and during production, as well as in stock testing. This ensures the selection of the highest-quality fabrics, resulting in durable, hardwearing products that perform consistently and resist breakdown. By producing long-lasting products, we reduce the need for replacements, contributing to the conservation of resources.


Among the 50 various testing methods are tests for abrasion resistance, tear strength, tensile strength, pilling resistance, colorfastness, and shrinkage. Quality testing is often over and above the minimum requirements set out by safety certifications and this is guided by our stringent quality policies and thorough quality check procedures.

Portwest has also achieved ISO 9001 certification, the world's leading Quality Management Standard that outlines the essential requirements for an effective quality management system.

### CHEMICAL MANAGEMENT

65% of our garments carry the OEKO-TEX® Standard 100 label, guaranteeing that every component of this product has been tested for harmful substances.

Every component of an article must comply with the strict OEKO-TEX® test criteria: whether the coating, outer material, stitching, or zipper.

These globally standardized criteria are updated at least once a year based on new scientific information or statutory requirements. 

After extensive research and testing, Portwest has switched our durable water repellent (DWR) garments to a new finish, called Texpel Eco, which is free from PFAs chemicals, dubbed "forever chemicals", due to their persistent presence in the environment.

We continue to test new PFC-free technologies for other products categories.



# FABRICS AND MATERIALS

As part of our dedication to increase the use of sustainable materials, we have introduced new products using recycled and certified materials.

The use of recycled polyester produced from post-consumer waste, requires fewer resources than that of new fibers and generates fewer CO<sub>2</sub> emissions. In the right conditions, recycled polyester can be recycled again, creating a closed-loop system. Additionally, diverting waste from landfill reduces soil contamination, as well as air and water pollution.



## THE MICROFIBER CONSORTIUM



Portwest became a signatory of the Microfiber 2030 Commitment in 2024.

Tiny fibers are released from natural, synthetic, and man-made cellulosic textiles throughout the product lifecycle. These are widely referred to as microfibers, microplastics, or fiber fragments.

Microfibers from all types of textiles can enter the environment and potentially harm ecosystems, wildlife, and humans.

Through our collaboration with The Microfiber Consortium, we are conducting research and contributing to industry knowledge with the aim of reducing microfiber shedding across our own ranges of products.

## GRS CERTIFICATION

Using Global Recycled Standard certified fabrics gives more visibility on responsible social, environmental, and chemical practices in the production of fabric using recycled materials.

All our GRS certified recycled polyester is 100% post-consumer waste and has full certification.



## RESPONSIBLE PACKAGING

As a global manufacturer, replacing our packaging materials with compostable and recyclable components is key to ensuring an environmentally conscious supply chain.

### UK PLASTICS PACT

We continuously strive to introduce more sustainable initiatives into our supply chain, including signing the UK Plastics Pact. This is a bold initiative bringing together the entire plastics packaging value chain behind a shared vision and committing to a set of ambitious targets.

## RECYCLABILITY AND RECYCLED CONTENT

Portwest is committed to choosing packaging materials with recyclability and circularity in mind. We use materials that are widely recyclable well as packaging made from recycled materials wherever possible.

### COTTON STRING

We introduced 100% cotton string that is biodegradable, thus eliminating single use plastic lock pins.

### LDPE POLYBAGS

Recycled LDPE is a material which is created from post-consumer plastic waste. Our recycled LDPE polybags are GRS certified and are sourced from LDPE films and are fully recyclable.

Any custom products can be shipped in bulk in one plastic bag, saving costs and the planet. Ask your ASM for more details.

### MOISTURE CONTROL

Portwest has removed all single-use silica gel packets from our products and replaced them with 100% natural Dri-Clay packets. These packets are biodegradable and plastic free.

## SUSTAINABLE SOURCING



**The Corporate Sustainability Due Diligence Directive (CSDDD) requires companies within its scope to conduct human rights and environmental due diligence.**

This includes identifying actual or potential adverse impacts, and prevent, mitigate, and minimize the extent of these impacts within their own operations, their subsidiaries, and their chain of activities.

### FROM 2027:

Portwest welcomes the new CSDDD legislation and while we are three years away from falling into scope, we are accelerating our efforts for increased visibility, transparency, and due diligence in line with these new requirements.



Owning our own manufacturing and warehousing facilities means Portwest has total control over working conditions and terms of employment for all employees, guaranteeing ethical practices.

This is supported through annual audits and various certifications. There are more details on this in Our People pillar. For partner manufacturing sites (Tier 1), Portwest has implemented strict social and ethical audit requirements and have requested suppliers to work towards ISO 14001, ISO 9001, and ISO 45001 standards. We are also engaging with Tier 2 material suppliers to implement the same standards and plan to extend these requirements across the entire supply chain.

Through providing greater transparency and visibility, we can maintain trustworthy partnerships with our suppliers and stakeholders, ensuring quality and mitigating risk. Portwest has embedded processes to ensure that products are produced in an ethical and responsible manner.


# OUR PEOPLE

**As a global company, we recognize that we have a significant responsibility to safeguard all our employees at all sites.**

We have stringent policies in place to ensure the health, safety, wellbeing, and ethical practices at all our operations. We are voluntary members of independent monitoring organizations who oversee our global compliance with these policies.

Our fully owned factories are audited using the Sedex Members Ethical Trade Audit (SMETA), a social auditing framework that aims to support business practices across labor standards, universal rights, management systems and health and safety. Sedex and SMETA are underpinned by the Ethical Trading Institute and the Internal Labor Organisation.

Portwest has also achieved the WRAP Gold Standard, the world's largest, independent, factory-based compliance program for responsible production in the sewn product sector, at our largest manufacturing facility in Bangladesh.

As Portwest continues to grow, we continue to invest in health and safety, making the lives of our colleagues better every day. Our on site health and safety teams are responsible for implementing improvement projects, ensuring all health and safety training is in place and are putting safety at the forefront of our operations. Our Global Health and Safety manager works alongside our operational teams ensuring consistent standards are adhered to and is continuously working to enhance our reporting systems to meet regulatory requirements.

Portwest has implemented ISO 45001 at sites covering over 51% of our employees, which is an International Organization for Standardization standard for management systems of occupational health and safety.

From backing local sports teams, to getting involved in local charities, philanthropy is a core value of Portwest and its global team. Every year we participate in sponsorship and charitable activities, big and small, across the world.

In 2021, Portwest entered into a major sponsorship with Mayo GAA. The Gaelic Athletic Association (GAA) is Ireland's largest sporting organization and is celebrated as one of the greatest amateur sporting bodies. It is a grassroots organization that encourages inclusivity at every level, bringing together people from young beginners to senior athletes and beyond, promoting community, connections and health.

## 120 YEAR SPONSORSHIP

To commemorate 120 years of business, Portwest launched the 120 Years Sports Sponsorship program. This unique project is about partnering with 120 clubs and athletes to provide them with the necessary resources they need to excel in their sports.





## CONSTRUCTION READY

Portwest is proud of its partnership with Construction Ready, a vital Atlanta-based non-profit organization. This collaboration is a powerful demonstration of Portwest's commitment to safety extending beyond its product line and into the community, specifically supporting the next generation of skilled tradespeople.

Construction Ready is dedicated to providing accelerated training and career opportunities in the construction trades, equipping individuals from diverse backgrounds—including those in career transition, veterans, and out-of-school youth—with the skills and industry credentials needed for a career in the trades.

This strategic partnership provides tangible support where it is needed most. Portwest sponsors the non-profit by donating essential safety gear, notably Type II safety helmets, to program participants. A key highlight of this collaboration is the annual Construction Ready Career Expo, where Portwest sponsors SkillsUSA Georgia's young competitors. By providing this crucial PPE, Portwest not only emphasizes the paramount importance of on-site safety from day one but also ensures that future tradespeople are properly equipped to begin their stable and rewarding careers. This initiative aligns perfectly with Portwest's mission to deliver reliable safety solutions and directly aids Construction Ready's goal of addressing the critical labor shortage in the trades by cultivating a skilled, safe, and job-ready workforce.



## THE OLIVE BRANCH FOR CHILDREN

As we establish our presence in Tanzania, Portwest is proud to partner with The Olive Branch for Children (TOBFC) Ireland, a registered charity that raises funds and connects volunteers to support TOBFC's meaningful work in Tanzania. TOBFC works with remote communities in rural Tanzania to implement sustainable programming that improves lives and disrupts the cycle of poverty. Their numerous education programs empower children and youth to create the change they want to see for themselves, their families, and the communities where they live. Through their Montessori Kindergartens program, TOBFC partners with 20 different communities to provide early childhood education, ongoing teacher training and up-to-date teaching materials. In 2023, Portwest supported 714 students beginning their successful educational journey in Montessori Kindergartens.

Portwest is committed to doing business in a fair and transparent manner. We provide anti-corruption & anti-bribery training to all relevant employees.


## WHISTLEBLOWING
